The Board had the Breton Fire Chief look at it. Liability issues were discussed. Administration is to send a letter to the Ag Society regarding the repair work and liability issues. Diane Bogart has confirmed that she is interested in continuing to operate the restaurant under the same terms and conditions of the 2017 Articles of Agreement.
