a. Municipal Accountability Program (MAP)

Debbie McCann, Municipal Accountability Advisor provided council with a summary of the purpose of the Municipal Accountability Program.

The Municipal Accountability Program will review municipal processes and procedures to help develop knowledge of mandatory legislative requirements to support municipalities with their legislative compliance. Under Section 571 of the Municipal Government Act the Minister ordered that a multi-year cycle review be conducted on municipalities with populations of 5,000 or less. Municipal Affairs will provide a customized MAP report that will identify areas of compliance and will include recommendations and resources to assist the village in remedying any legislative inconsistencies.
