9) New Business

a) Proposed Subdivision – Deer Crossing Phase 3

West Central Planning advised that a motion of council is required to approve the plan and the recommended conditions in order to send out the proposed subdivision formally.

MOVED by Councillor Plaquin that the Council of the Village of Breton approve the draft approval of the proposed subdivision of part of NE 2-48-4-W5M and will complete the following conditions: Engage an Alberta Land Surveyor to prepare a plan of subdivision for registration at Land Titles Office as shown on WCPA drawing dated October 25, 2016 and submit it to this office for final approval and engage an Alberta Land Surveyor to prepare a utility plan for registration at Land Titles Office concurrently with the plan of subdivision and pay any outstanding taxes on the property and pay an endorsement fee of \$200 per lot and the remainder (Total: \$4200) to WCPA when the plan is submitted for final approval and municipal reserves are not owing as it was fully dedicated under plan #122.3297 (VB/10/01).

b) Asset Management Capacity Building Cohort Program

Alberta Urban Municipalities Association (AUMA), Rural Municipalities of Alberta (RMA) and Infrastructure Asset Management Alberta (IAMA) are organizing an asset

management capacity building cohort. The purpose of the cohort is to support a small group of municipalities in collaboratively learn the basics of asset management, receive support in developing the tools needed for asset management and to improve asset management capacity.

Participation in the cohort is free aside from travel expenses.

The following resolution is required for the application process.

Be it resolved that the Council of the Village of Breton directs staff to apply for the asset management cohort program opportunity from the RMA, AUMA and IAMA.

Be it therefore resolved that the Village of Breton commits staff and other personnel to participating in the asset management cohort program to advance our asset management program.

Be it further resolved that the Village of Breton commits financial support from its budget toward the costs of this initiative for staff travel and accommodation.

MOVED by Deputy Mayor Young that the Council of the Village of Bretom approve the resolution as proposed by the Asset Management Capacity Building Cohort Program and that the village participate in the application process.

e) Lease Agreement Renewal – Miss Joanne's School of Dance

- 2. Under obligations of the Lessor amend Section 2.1.1 the renewal to "until such time as both parties agree by joint written consent to amend, cancel and/or terminate this agreement".
- 3. Under obligations of the Lessor remove Section 2.1.2
- 4. Under obligations of the Lessor amend Section 2.1.3 to "notify the Lessee of increase in rent. Notice shall be made in writing no later than June 30 and increases in rent shall be effective in the year following the year that written notice is given."
- MOVED by Mayor Power that the Council of the Village of Breton approve the renewal lease agreement with Miss Joanne's School of Dance with the following amendments: under definitions remove the designated waiting area and under obligations on the Lessor amend Section 2.1.1 the renewal to "until such time as both parties agree by joint written consent to amend, cancel and/or terminate this agreement and under obligations of the Lessor remove Section 2.1.2 and under obligations of the Lessor amend Section 2.1.3 to "notify the Lessee of increase in rent. Notice shall be made in writing no later than June 30 and increases in rent shall be effective in the year following the year that written notice is given.

f) Waiting Area Lease at the Breton CentraPlex Proshop

Previously council directed that the village look into accommodating parents/guardians and students that attend dance lessons at the Breton CentraPlex.

Mayor Power met with Shayanne Sheaves and Deanne Wirsig to discuss arrangements to lease a portion of the proshop as a waiting area for dance students and parents/guardians of dance students. An agreement was reached for a one year term ending on the 15th day of April, 2019.

That the Council of the Village of Breton enter into a lease agreement to lease a portion of the proshop at the Breton CentraPlex to provide a waiting area for dance students and parents/guardians of dance students at no cost for a one year term ending on the 15th day of April, 2019.

This initiative is intended to provide a community an opportunity to create and enhance local partnerships and collaborate with Alberta Health Services to address community wellness through a health promotion perspective.
